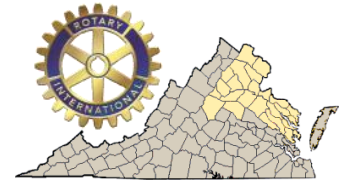

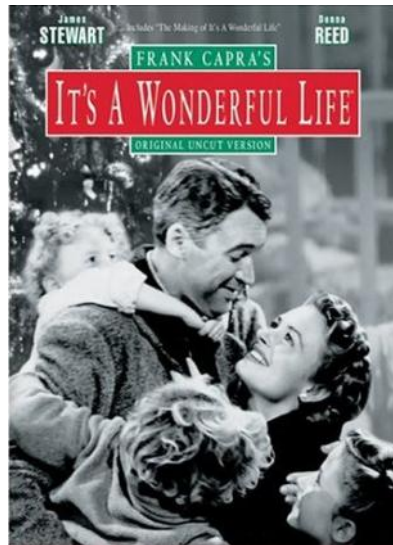

The following clubs were recognized for their support of The Rotary Foundation in 2009-10.

**100% Every Rotarian Every Club (EREY)** - To qualify every club member made a contribution to Annual Programs Fund and have per capita giving of at least \$100 as of June 30. Worldwide 1,113 Rotary clubs received this recognition (there are over 34,000 Rotary clubs). The 100% EREY clubs in District 7610 in 2009-10 were: Alexandria, Bailey's Crossroads, Burke, Caroline County, Centreville, Charlottesville, Crystal City-Pentagon, Dunn Loring-Merrifield, Herndon, Manassas Bull Run, Mount Vernon, McLean, North Stafford County-Garrisonville, Rappahannock-Fredericksburg, Reston, Springfield, Stafford, Tysons Corner, Vienna, West Point, West Springfield.

**100% Rotary Foundation Sustaining Member Club** - To qualify every club member must make a contribution to the Annual Programs Fund of at least \$100 as of June 30. Worldwide 669 Rotary clubs received this recognition. The 100% Sustaining clubs in District 7610 in 2009-10 were Caroline County, Manassas Bull Run, McLean, Springfield, Stafford, West Springfield.

**Top Three Per Capita Clubs** – 1,555 Rotary clubs worldwide received this recognition. The top three per capita clubs in District 7610 in 2009-10 were: #1 Rosslyn-Ft. Myer – (\$881.47 per capita), #2 – McLean (\$838.31 per capita), #3 – Vienna (\$427.84 per capita).

The **Top Three Clubs in Annual Giving** were: #1 McLean — \$53,652, #2 Alexandria — \$52,308, #3 Vienna — \$26,098.

The **Top Three Clubs in Total Giving** were: #1 McLean — \$83,152, #2 Alexandria — \$56,358, #3 Annandale — \$32,475.

## Polio Eradication Will Save Up To \$50 Billion Worldwide

New study in *Vaccine* estimates up to 5.4 million lives and \$17 billion saved through NID vitamin supplements

A new study estimates that the [Global Polio Eradication Initiative](#) could prevent more than eight million cases of paralytic polio and save US\$40 billion to \$50 billion, if the wild poliovirus is eradicated in 2012 or shortly thereafter.

Published online this month in the *Vaccine* journal, the study, "[Economic Analysis of the Global Polio Eradication Initiative.](#)" is based on actual and projected immunization costs and polio incidence from 1988 through 2035. Low-income countries would account for about 85 percent of the savings.

The study also estimates that the distribution of vitamin A supplements during National Immunization Days—the "plus" in PolioPlus—has prevented from 1.1 million to 5.4 million child deaths and saved between \$17 billion and \$90 billion in disease treatment costs.

"Polio eradication is a good deal, from both a humanitarian and an economic perspective," says the study's lead author, Radboud J. Duintjer Tebbens, of the nonprofit Kid Risk Inc. "The GPEI prevents devastating paralysis and death in children and also allows developing countries and the world to realize meaningful financial benefits."

The study focuses on 104 countries, most of them lower-income, that have directly benefited from the GPEI since 1988 through reduced polio treatment costs and the prevention of lost productivity due to disability.

Not included in the study are the substantial benefits that continue to accrue in countries that have eradicated polio. In

2006, for example, estimates indicated that the United States had saved more than \$180 billion because of its investment in immunization to become polio-free.

The study was produced by Kid Risk Inc., the Delft University of Technology, the U.S. Centers for Disease Control and Prevention, and the GPEI.

The incidence of polio has fallen by more than 99 percent worldwide since the GPEI began in 1988. Indigenous transmission of the wild poliovirus persists only in relatively small areas of Afghanistan, India, Nigeria, and Pakistan. Until eradication is complete, however, all countries remain at risk for the importation of the virus, as demonstrated by the polio outbreaks in Tajikistan and the Republic of the Congo this year.

By the time the world is certified polio-free, Rotary's contributions to the global eradication effort will exceed \$1.2 billion. In addition, Rotary has mobilized hundreds of thousands of volunteers in support of immunization activities.

Rotary also plays a leading role in soliciting financial support from national governments, which has amounted to more than \$8.2 billion since 1988.

"This entire initiative began because of the vision of Rotary International," says Margaret Chan, director-general of the World Health Organization, who calls the more than 1.2 million Rotarians "tireless partners in the polio eradication effort."

## Rotary Vision Quest: 200 Clubs in 200 Days

Over one-third towards her goal, Colleen Bonadonna raises awareness for Rotary's PolioPlus Campaign

Google "Colleen Bonadonna" and "Polio" and you are likely to get hundreds of responses to your query. That is because West Point, VA, Rotarian Colleen Bonadonna is on a vision quest to visit 200 Rotary Clubs in 200 days. In February 2010, Colleen and her son traveled to India to participate in a National Immunization Day. In addition to administering polio drops to ensure children will never be infected with polio, Colleen and fellow Rotarians visited an orthopedic hospital and saw how reconstructive surgery allows patients, crippled by polio as children, to walk out of the hospital for the first time in decades.

Rotarians all over the world are eradicating polio one drop at a time. Colleen and her fellow Rotarians are in a race against time—a race to inoculate the last few million children against polio, before that disease claims even one more life or cripples even a single, additional child. Colleen is helping in a very special way by visiting 200 clubs in 200 days, pledging to donate to PolioPlus the cost of the meals when she is a guest speaker at a club. Help Colleen reach her goal, while, at the same time, helping Rotary reach its goal of eradicating polio.

## In Memoriam: Owen C. Shull

Reston Club's Charter President was Major Donor and an Arch C. Klumph and Bequest Society Member



Owen C. Shull, 77, a physician in Herndon for 39 years, died Monday, November 29, 2010. Owen grew up in Rotary. His father was a charter member of the Rotary Club of Herndon, which formed in 1935. Owen remembered as a child playing under the tables at Dranesville Tavern while the Rotarians held their meetings. He joined the

Rotary Club of Herndon and served as that club's President before heading up the project to start a Rotary Club in Reston. Owen served as the first President of the Reston Rotary Club in 1970. Owen was generous not only with his time, but in his commitment to financially support the programs of The Rotary Foundation. He was a Major Donor (Level Five), a member of The Rotary Foundation Bequest Society (Level Five) and an Arch C. Klumph Society Member.


## Online Contributions from 18-24 October Break Record !

**\$3.3 million raised for PolioPlus in seven days.**

During the week of 18-24 October, approximately \$3.3 million was raised in online contributions for PolioPlus. To honor World Polio Day on 24 October, The Rotary Foundation offered, for the first time, double [Paul Harris Fellow](#) recognition points for online-only contributions of US\$100 or more during that week.

The results represent a significant increase in online donations. To compare, \$660,000 in online donations to PolioPlus were made from January to September 2010.

As of 9 November, Rotarians have [raised about \\$152 million](#) for Rotary's US\$200 Million Challenge. These contributions will help Rotary raise \$200 million to match \$355 million in challenge grants from the Bill & Melinda Gates Foundation. The resulting \$555 million will directly support immunization campaigns in developing countries, where polio continues to infect, paralyze, and even kill children, robbing them of their futures and compounding the hardships faced by their families.

## Foundation Quick Tip: IRS Tax Deadline is Perfect Time to Give to The Rotary Foundation

Help achieve this year's Challenge Goal of \$225 per capita

Traditionally, December is the highest giving month of the Rotary Year. Last year, District 7610 Rotarians donated more than \$95,000 in December, alone. If donations reach that amount again this year, District 7610 will remain on track to reach its Challenge Goal of \$225 per capita by June 30.

Here are some tips to ensure contributions are posted by the IRS tax-year deadline of December 31.

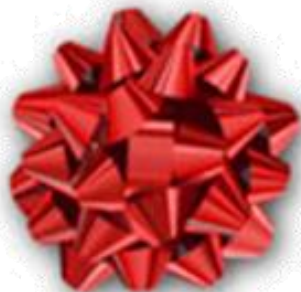

Your gift to The Rotary Foundation's Annual Programs Fund helps your neighbors at risk, whether they live around the corner or half-way around the world. Members who donate through their club dues have a reasonable expectation that their clubs will ensure their gifts will reach The Rotary Foundation in a timely manner.

When a club collects TRF contributions with club dues, it holds those funds in trust. **Clubs owe a fiduciary duty to donors** to ensure the donors receive their IRS tax receipts from The Rotary Foundation for the year in which they gave their gifts. The Foundation cannot send the receipt if the club does not send the donation to the Foundation.
